The abstract should not exceed 200-250 words and clearly outline the paper's purpose, methodology, and conclusions. It should also include 4-5 keywords and their classification in JEL.

Abstract submissions should be made in Microsoft Word format following the instructions provided and sent via email to <a href="mailto:infoconference@kub.edu.al">infoconference@kub.edu.al</a>
